- 4. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to the above office of Office of the Prime Minister and Council of Ministers, Singhadurbar, Kathmandu on or before 12:00 AM on July 10, 2021 (Asad 27, 2078).
- 5. Bids shall be opened in presence of Bidders' representatives who choose to attend on 2:00 PM on July 10, 2021 (Asad 27, 2078) at the office of Office of the Prime Minister and Council of Ministers, Singhadurbar, Kathmandu. Bids must be valid for a period of 90 counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 350,000 (Three Hundred and Fifty Thousand Only), which shall be valid for minimum 30 days beyond the bid validity period (i.e. Oct 7, 2021 Asoj 21, 2078)
- 6. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
