2. Bidding is open to all eligible bidders from Nepal.
3. **Office of the Prime Minister and Council of Ministers, Singhadurbar, Kathmandu** invites electronic bids from eligible bidders for **Interior Design Works of Harka Gurung Hall of PMO, Singhadurbar, Kathmandu** (Contract ID: 01/NCB/WORKS/OPMCM/078-79). Under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. **77,000,000.00**

Minimum Work experience of similar size and nature: **One Multistoried Building Project including Electrical, Sanitary, HVAC, Fire Fighting and Interior works** within the last ten (10) years, with a value of at least NRs. **41,000,000.00 (excluding VAT)**.

Only eligible bidders with the following key qualifications should participate in this bidding.

4. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate bids, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in eGP system as per the provision of ITB 21 of the Bidding Document.

7. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **26-05-2022 12:00** at 12:00 hours. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend on **26-05-2022** at **14:00 hours** at the office of **Office of the Prime Minister and Council of Ministers, Singhadurbar, Kathmandu**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 1,600,000.00** which shall be valid for **30 days** beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
