4. Pre-bid meeting shall be held at Office of the Prime Ministers and Council of Ministers at **18 December, 2022 (Poush 3, 2079) at 11:30 AM.**
5. Interested Bidders shall submit electronic bids through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 PM on 25 December, 2022 (Poush 10, 2079).**
6. The bids shall be opened in the presence of Bidders' representatives who choose to attend at **14:00 PM on 25 December, 2022 (Poush 10, 2079).** at the office of the Prime Minister and Council of Ministers, Singhadarbar, Kathmandu. Bids must be valid for a period of 90 from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 5,00,000.00 (Five Lakhs), which shall be valid for 30 days beyond the validity period of the bid i.e., **23 April, 2023 (Baisakh 10, 2080).**
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
